Order

The MOIA office order No. F. No. OI-11012/10/2013-EP, dated 12.03.2015 para (iv) provides that

*"Recruitment of Indian Nurses through any other Indian Recruiting Agents (RA) would be allowed for a specific country whenever such a proposal is received from that country, subject to the issue of a country specific order from the Ministry of Overseas Indian Affairs".*

2. In pursuance of para (iv) of the Order dated 12.03.2015, as above and subsequent request dated 23.11.2015 and 18.01.2016 received from Ministry of Health (MoH), Government of Saudi Arabia, provisional approval of the Competent Authority was granted to Ministry of Health, Government of Saudi Arabia for the recruitment of Indian Nurses vide this Ministry's letter of even number dated 22.01.2016 through the following 13 Indian Recruiting Agents (both Govt RAs and Private RAs), after Ministry of Health (MoH), Government of Saudi Arabia registered in the e-migrate system, as a Foreign Employer (FE) duly validated by the Indian Mission in Saudi Arabia.

3. Whereas there is an unsettled complaint pending against M/s Santosh Travels, License No. B-0114/MUM/PER/1000+/2/2775/90 in this office; and whereas the same has not yet been settled, M/s Santosh Travels cannot be granted permission for recruitment of Nurses for Ministry of Health (MoH), Government Saudi Arabia at present. Their case will be considered later after settlement of grievances, if necessary.

4. The Emigration Clearance (EC) of the nurses recruited by the remaining 12 above mentioned RAs, shall be allowed subject to the compliance with the conditions contained in this Ministry's letter No. Z-11025/82/2015/Emig dated 22.01.2016 and 02.02.2016.

5. This Order of grant of permission to recruit Nurses for Ministry of Health (MoH), Government of Saudi Arabia by the 12 RAs mentioned above, shall be valid upto 30.06.2016 and thereafter stand automatically withdrawn, if not re-validated further by the Ministry of Overseas Indian Affairs on the specific request of the Ministry of Health, Government of Saudi Arabia. In case any violation of the conditions of the Ministry's letter dated 22.01.2016 and 02.02.2016 is brought to the notice of the PGE/ PoE offices, this country specific order shall stand withdrawn immediately, after prior notice to the Ministry of Health, Government Saudi Arabia.
